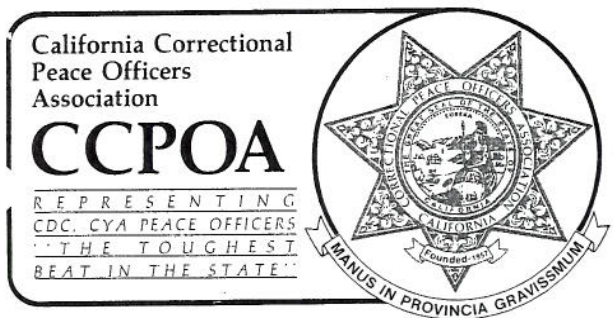


Dear Messrs. Gilb, Tilton, Lear and Monday:

On December 27, 2007, I sent you a letter requesting information pursuant to the Ralph C. Dills Act. The information requested related to the actions taken by the State to implement the last, best and final offer. A copy of that letter is enclosed for your convenience. As of the date of this letter I have received only a letter dated January 10, 2008, which was actually received in this office on January 14, 2008. This letter is signed by Julie Chapman and states only that you are "reviewing and analyzing" our requests. Your actions in responding to this request are sadly similar to your actions in responding to our information requests during negotiations.

Please be aware that this letter constitutes our final request for the information listed in the December 27, 2007 letter. Failure to provide the requested information by

January 25, 2008 will cause the California Correctional Peace Officers Association (CCPOA) to proceed to enforce all rights available under the Ralph C. Dills Act.
